It's a bright new day for the Chamber, and I know you'll share in my excitement for Bradley stepping into this role. He is precisely the leader the Mobile Chamber needs, and he has all the tools needed to support the business growth that will

# AIRBUS ANNOUNCES NEW ASSEMBLY LINE AND 1,000 NEW JOBS



The Airbus announcement was made at Bishop State Community College alongside the latest class of FlightPath9, an ongoing recruiting effort to train and educate local students with the skills needed to work in the Airbus manufacturing facility.

Airbus announced a third final assembly line will be built at the Mobile Aeroplex at Brookley, as the airplane manufacturer ramps up production in Mobile to 20 planes per month.

The new A320 final assembly line (FAL) will create 1,000 new jobs.

"The fact that Mobile will lead our unprecedented global production rate increase in the coming years is a tribute to the world-class labor force in Alabama," said **C. Jeffrey Knittel**, chairman and CEO of Airbus Americas. "I'm so proud of our Mobile employees for proving through years of hard work what Alabama is capable of, and I'm also immensely grateful to state leadership for making Alabama such a great place to invest and do business."

Airbus will break ground on the 350,000-square-foot facility in the first half of 2023, with planes slated to roll off the new final assembly line in the second quarter of 2025. The expansion will also include a new paint shop and major modifications to its existing hangar.

"It's wonderful to see Airbus continue to grow its only U.S. airliner manufacturing operation with another expansion in Mobile," said **Gov. Kay Ivey**. "This growth is made possible

by the company's skilled workforce in Alabama and our commitment to developing a pipeline of future aerospace workers."

Airbus produced the first Alabama-built A320 aircraft in 2015, and it launched production of the A220 single-aisle passenger jet in Mobile in 2019, with a new assembly line specifically for the A220 opening the next year.

Airbus has invested more than \$1 billion in its Alabama manufacturing facility. **Greg Canfield**, secretary of the Alabama Department of Commerce, said the state's aerospace/aviation industry is primed for growth.

"Aerospace industry growth continues to be a high-value opportunity for Alabama, not only in terms of capital investment but also in job creation," he said. "There are a lot of exciting things going in aerospace and aviation in the state, and we're seeing that today with the expansion at Airbus."

"Mobile is quickly becoming a global epicenter for the aerospace industry, and the addition of a third final assembly line in Mobile is a testament to our area's workforce," said **David Rodgers**, vice president of economic development at the Mobile Chamber.

# **AUSTAL AWARDED \$230.5M U.S. NAVY CONTRACT**



Austal USA announced it was awarded a \$230.5 million contract for the detail design and construction of EPF 16, the Navy's newest Expeditionary Fast Transport (EPF) ship.

Having already successfully delivered 12 EPFs on schedule and on budget, Austal has three additional EPFs currently under construction.

EPFs have operational capabilities to conduct a variety of missions, including humanitarian assistance, disaster relief, maritime security, surveillance, command and control and counter-narcotics missions.

"Like the previously delivered EPFs, EPF 16 will benefit from the serial production of this program, resulting not only in a world-class ship but also providing assurance to the U.S. Navy that capability will be delivered on budget and on schedule," said Austal USA President Rusty Murdaugh. "Our reputation for delivering quality is a direct reflection of the commitment and dedication of our talented shipbuilders and suppliers."

EPF 16 will be the third ship constructed in the Flight II configuration. Flight II ships will enhance the original capabilities of the Spearhead class through incorporation of reconfigurable spaces for operating rooms and postsurgical recovery efforts. Combined with the ship's flight deck, which is capable of landing V-22 aircraft, Flight II ships provide versatility.

Construction efforts on EPF 16 are expected to commence later this year, with delivery projected for 2025. Austal USA is currently under contract to build additional EPFs, the Independence-variant Littoral Combat Ship (LCS) and the Navajo-class Towing, Salvage and Rescue ships (T-ATS) and is supporting Navy unmanned vessel programs leveraging its advanced machinery control system.



# APM TERMINALS TO EXPAND CAPACITY AT CONTAINER TERMINAL

APM Terminals and the Alabama Port Authority have signed an agreement to add 32 acres to the current 134-acre container terminal yard to keep pace with future demand. The expansion will bring the facility's annual throughput capacity to one million Twenty-foot Equivalent Units (TEUs) and will allow the terminal to handle cargo containers from larger ships (14,000 TEU ships).

The announcement includes plans for an expansion of the terminal yard adding approximately 80 new jobs with an average annual salary of \$143,000. The expansion also includes adding two new super post-Panamax ship-to-shore cranes (handling vessels of about 22 or more containers wide) and related support equipment to complement the current four cranes.

The \$104 million terminal expansion will begin later this year. The first 19 acres are expected to be completed in 2024, and the remaining 13 acres by early 2025.

"APM Terminals is extremely excited by this next step," said **Brian Harold**, managing director of APM Terminals Mobile. "This is our third expansion in six years, which underscores the high level of demand by the shipping community to utilize the Mobile gateway. We have high growth aspirations for our Mobile facility,

and this next infrastructure improvement will help ensure that we meet those expectations in full."

"We have a great partner in APM Terminals and incredible community support to further world-class infrastructure for our carriers and shippers," said **John C. Driscoll**, director and chief executive officer of the Alabama Port Authority. "This added capacity will allow our port to keep pace with demand and maintain fluidity and service for our customers."

According to APM Terminals, container volumes through the port in April 2022 showed a 39.7 percent increase over April 2021 volumes. The port's intermodal container transfer facility posted 112.6 percent growth during the same period. Refrigerated cargo also maintained its double-digit growth, posting a 57.9 percent gain over the same period.

"This is great news for the future of economic development in our region," said Mobile Chamber Vice President of Economic Development **David Rodgers**. "Additional capacity at the port makes Mobile even more attractive to site selectors considering our area for future growth."

# DISTRIBUTED LEDGER BRINGS BITCOIN MINING TO ALABAMA AND MOBILE

Distributed Ledger Inc. (DLI), a blockchain and cryptocurrency service provider, announced Bitcoin mining is coming to the City of Mobile, in partnership with the GulfQuest Maritime Museum Board, in the form of a new, sustainable revenue source poised to fuel growth for the next decade.

GulfQuest plays an integral role in portraying city and state history, while keeping its eyes on the area's maritime industry's competitive growth. Maersk Shipping, the world's largest container shipper, already has 50 percent of all containers globally on its dynamic TradeLens Blockchain.

DLI is using a modified shipping container to house 100 of Bitmain's Antminer S19s, all of which will be fully air-cooled on-site. These machines will mine Bitcoin around the clock as DLI lays the groundwork for government funding and subsequent infrastructure funded through crypto mining revenue.

"The high-tech revenue source of Bitcoin mining is tied to the education, adoption and growth of the next level of encrypted and secure growth of the internet, designed to provide a dramatic time and cost savings and a higher level of security for the global maritime industry," said former City of Mobile Mayor **Mike Dow**, the current executive director of the GulfQuest Board.

"We couldn't be more excited at the opportunity to bring blockchain technology and Bitcoin to the state of Alabama and, more importantly, the great city of Mobile," said **Mike Francis**, CEO of DLI. "Our goal at DLI is simple: help companies and institutions with the understanding, accumulation and usage of cryptocurrency."





# MASTER BOAT BUILDERS DELIVERS HYBRID TUG

Master Boat Builders Inc. announced it delivered Spartan, an electric-hybrid tugboat, to Seabulk Inc., a British Columbia company.

"The Spartan is the latest addition to our fleet and constitutes the first of two hybrid, diesel-electric vessels commissioned from Master Boat Builders," said **Daniel Thorogood**, chief executive officer of Seabulk. "She is representative of their advanced workmanship and ability to deliver modern, cuttingedge marine technology. We look forward to continuing to deliver service excellence and offering our customers a more sustainable towing solution."

"As the maritime industry continues to evolve and modernize its fleet, Master Boat Builders is proud to deliver this hybrid tugboat, which will serve as the most efficient technologically advanced tug operating in the U.S.," said **Garrett Rice**, president of Master Boat Builders. "Spartan is the latest in a series of innovative and alternative-powered work boats that we are constructing and that we will continue to deliver as demand in this market expands."

Spartan was designed by Robert Allan Naval Architects & Marine Engineers. The tug is built to meet United States

Coast Guard regulations and is classed through the American Bureau of Shipping, including escort notation. The vessel has an overall length of 98 feet, beam of 43 feet, and bollard pull of 90 tons. The integrated hybrid propulsion system was provided by Thompson Tractor and includes two EPA Tier 4 certified Caterpillar 3512E main engines, each producing 2,550 horsepower, and two Berg MTA 628 azimuth thrusters, three Caterpillar generators and two ABB propulsion motors and associated variable frequency drives.

Berg's hybrid electric propulsion system includes high levels of redundancy for safety as well as the ability to switch seamlessly between operating modes with the push of a button. A vessel can run on main engines only, gensets (engine-generator set) only, or a combination of the two, optimizing energy use across the entire operating profile.

"This has been a landmark delivery for Master Boat Builders in next-generation tug construction, and a testament to the value of teamwork," said Rice. "The approach was collaborative throughout the design, engineering, and building phases and we look forward to completing work on the second of these innovative Seabulk tugboats later this year."

# **BRADLEY BYRNE** NAMED MOBILE CHAMBER PRESIDENT AND CEO

**Bradley Byrne** is no stranger to the Mobile Chamber and its mission to be a leading catalyst for economic expansion in the Mobile area. In fact, he credits his first exposure to the Chamber with igniting his passion for public service. Now, three decades later, his career has come full circle and brought him back to the Chamber as its new president and CEO.

"I first got involved with the Chamber in the late '80s at the encouragement of former Congressman Jack Edwards," said Byrne. "I was working as a lawyer and had not thought to get involved until I spoke to him. I didn't think he knew who I was, but he eventually became my mentor."

Byrne volunteered to serve on the Chamber's Education Committee, whose mission was to help improve Mobile County Public Schools. He ended up chairing the committee. "I believe this involvement led me to want to run for the Alabama State Board of Education, then run for Alabama State Senate, then serve as chancellor of the Alabama Department of Postsecondary Education and then Congress. The leadership skills I learned from working with the Chamber seemed a natural progression as I watched the Chamber be the driving force for improvements in Mobile."

Another way Byrne was involved with the Chamber was through its Leaders Exchange trips, where local elected officials and

business leaders visit a similar city to learn from its business leaders and elected officials on lessons learned and best practices. The trips started in 1987 to Jacksonville, Fla., and have continued nearly every year since (except for 2001).

"I was on that first trip to Jacksonville and was on every trip through 1996," Byrne said. "Those trips are so valuable to help us as a community work together and be a part of a team with a common purpose – and that purpose is to grow our area."

Looking back now, Byrne said he can see where the Chamber has laid the groundwork for some of the projects being celebrated today, by the collaboration of Team Mobile and through these Leaders Exchange trips.

A native of Mobile, Byrne has more than 30 years of experience as an attorney in private practice and more than two decades of public service.

"I became a lawyer and I practiced labor employment law," said Byrne. "In this practice, I was able to help people in real-world circumstances. I studied public policy in school, where politics would have been natural for me to pursue, but I stayed a lawyer first. As such, I learned real-world applications to the law and how labor laws affect people."


#### **JUNE 2003 - LEGISLATIVE** TASK FORCE MEETING

Byrne says he learned a lot about business from his father, who sold trucks at a dealership. He said his father taught him the importance of teams, and that we all work better when we work together. "Everyone in a team plays an important role and listening to all team members benefits all," he said.

He finds it inspiring to watch the evolution and years of hard work put into moving Mobile forward through Team Mobile.

From 2002 to 2007, Byrne was a member of the Alabama State Senate. Prior to that, he served on the Alabama State Board of Education for two terms. In 2007, Byrne was named chancellor of Alabama's two-year college system, where he restructured the system to make it more accountable.

Byrne represented southwest Alabama in the U.S. House of Representatives from 2014 to 2021. He was appointed by two speakers to the powerful Rules Committee, which considers all bills and determines whether, and in what order, they are considered on the House floor.

With his background as a labor and employment attorney and in education policy, he was appointed to the Education and Labor Committee, and he chaired the Workforce Protections Subcommittee. Byrne was known as a fierce supporter of business and industry and led initiatives that have increased access to education and job training, benefiting Alabama's workforce and businesses alike.

But Byrne said his greatest accomplishment while in Washington, D.C., was the four terms he spent on the House Armed Services Committee. He said the spending bills he helped pass turned around the lack of investment in our armed services.



# OHC FOCUSES ON CONVENIENCE FOR OCCUPATIONAL HEALTH SERVICES

Companies large and small are bolstering benefits packages in the hopes of maintaining and recruiting top talent within their ranks, and healthcare is a major component of those incentives. Fewer and fewer industry leaders are putting the onus on their employees to navigate insurance requirements like physical exams, vaccinations and drug tests alone, which is how Occupational Health Center has enjoyed sustained success for more than a decade.

The Brookley Aeroplex-based company is the Mobile Chamber's Small Business of the Month.

The company has always operated under the "glad you asked" philosophy, according to one of its founders, **Dr. Terry Taylor**, who serves as OHC's medical director.

"We like to say, 'We're glad you asked, so how can we help you?" he said.

Taylor is one of several providers working at OHC, which approaches patient care in a number of ways. The company operates healthcare centers in Mount Vernon, Alabama, and Pascagoula, Mississippi, in addition to its headquarters on Michigan Avenue across from the entrance to Brookley. Patients

can access healthcare in these traditional medical centers, but OHC also operates on-site clinics with its industrial clients, so employee services are available at the workplace. And the company also has a mobile unit that can be scheduled to reach sites when physical exams and hearing tests are needed.

"What we want to do is offer quality services in a timely manner and focus on excellent communication with the employers," Taylor said.

In 2009, he and one of his co-founders were working in occupational health for a local hospital system when they decided they wanted to strike out on their own, organizing a board of directors including five physicians to help guide the company. Its services were loosely based on others Taylor and his partners saw in operation elsewhere in the marketplace, but OHC quickly became a unique, full-service organization no matter where its client base might be located.

The business model focuses on convenience in providing employee evaluation and care, Taylor said, which is why there are larger health centers near the industrial complexes in north Mobile County as well as the aerospace and shipping hubs in south Mississippi and downtown Mobile.

"The safety program for an employer starts with the hiring process," Taylor said. "So using a facility that has skilled occupational medicine providers helps them make sure it's a good fit for the worker for the job they want to do."

That long-term relationship with the employee could begin as early as a pre-employment drug screening and continue through such unforeseen issues as workplace injuries.

Part of OHC's success has been achieved due to its proximity to emerging industries, such as Airbus and Austal, both of

which are clients. When Taylor and his partners saw that Brookley was expanding, they planned accordingly. He and Dr. Alexander Minney became certified by the Federal Aviation Administration to provide physicals to pilots.

Because of its status within various industries, Taylor said the Mobile County Health Department reached out to OHC during

the recent coronavirus pandemic to help administer free vaccines throughout the community. The company continues to offer vaccinations and booster shots each Thursday without need of appointment. OHC also supports initiatives such as Breast Cancer Awareness and the Tunnel to Towers Foundation, which supports military veterans and first responders nationwide.

#### **City of Mobile** cityofmobile.org

The City of Mobile's



Self Service (CSS), is a one-stop shop for doing business in the city limits. A business license is required to operate each separate business activity within the city, including acquiring a business license and filing and paying taxes.

#### (Remember: businesses operating within the city limits need both a city license and a county license.)

The state, counties and municipalities regulate businesses within their boundaries. A company acquiring a license from the City of Mobile satisfies the city's requirement however the city is within the confines of Mobile County and the State of Alabama and is subject to the license requirements of those jurisdictions also.

If you are a developer, the city online portal, Build Mobile, lets you track, manage and view plans, permits, inspections and code



enforcement cases throughout the building process, as well as pay invoices and request an inspection on active permits.

#### **Mobile County**

A privilege (business) license is required for all businesses operating in Mobile County. On the county website, you can acquire a business license and file and pay county sales taxes online. Business owners are required to pay taxes on inventory of personal property (i.e. office

The county's inspection services department regulates the construction, demolition, alteration and repair of structures in unincorporated Mobile County. This includes plan review, permitting and inspection of all work that is subject to the adopted building codes and flood damage prevention.

#### State of Alabama

Any business that hires employees and pays wages in Alabama needs an Alabama income tax withholding number to hold and remit taxes to the Alabama Department of Revenue. My Alabama Taxes (MAT) is the state's electronic filing and remittance system for the filing of state, city and county sales, use, rental and lodging taxes. Proprietors, partners, corporate shareholders and others must report estimated earnings and pay income tax each quarter.

#### **Federal**

#### irs.gov

An Employer Identification Number (EIN) issued by the IRS is used to identify a business entity and is needed to pay federal withholding tax.

A sole proprietor may use his or her Social Security number as the EIN, unless the proprietorship has employees or is required to file any business tax forms. A partnership or corporation must have an EIN whether or not it has employees.

Employers are required to withhold federal income tax (FIT), Social Security and Medicare taxes (FICA) from the wages paid to employees. FICA taxes are paid by both the business and the employee. All employees must have a Social Security number. If self-employed, contributions are made through the self-employment tax reported on the employer's quarterly tax return.

#### E-Verify e-verify.gov

E-Verify is a web-based



system that allows employers to confirm the eligibility of newly hired employees to work in the U.S. by electronically matching information provided by employees on the Form I-9 against records available to the Social Security Administration (SSA) and the Department of Homeland Security (DHS).

While E-Verify is a voluntary program (with the exception of employers working on federal contracts or subcontracts) under federal law, Alabama employers are required under Alabama law to use E-Verify to verify the work eligibility of all employees. Alabama employers may use the federal E-Verify website (e-verify. gov) or businesses with 25 or fewer employees may elect to use the Alabama E-Verify Employer Agent Service (verify. alabama.gov).

#### Form I-9

Federal law requires that every employer who recruits, refers for a fee, or hires an individual for employment in the United States must complete Form I-9,

Employment Eligibility Verification. Form I-9 is used to document and verify the identity and employment authorization of individuals to work in the United States. This includes citizens and noncitizens.

#### **Insurance**

Business owners with employees may be required to provide worker's compensation insurance. Companies with five or more employees, part-time or full-time, are required to have worker's compensation insurance, obtained through a local insurance agency.

#### **Occupational** Safety & Health

All businesses with employees are required to comply with state and federal regulations regarding the safety and protection of employees.

#### **Americans with Disabilities Act (ADA)**

#### ada.gov

The Americans with Disabilities Act prohibits discrimination in employment on the basis of disability, including handicap accessibility.

#### **Equal Employment Opportunity Commission (EEOC)**

#### eeoc.gov

Employers must be aware of equal employment opportunity regulations. It is illegal to discriminate against a job applicant or an employee because of the person's race, color, religion, sex (including pregnancy), sexual orientation, national origin, age (40 or older), disability or genetic information, among other issues.

#### **Patient Protection** and Affordable Care **Act (PPACA)**



The PPACA (Affordable Care Act) was a health care reform bill enacted in 2010, making significant changes to the American health care system. An employer-sponsored health plan may be "grandfathered" and exempt from the requirements of the Act if it has remained essentially unchanged in carrier, benefits, co-pay amounts etc. since March 2010. Otherwise, companies that maintain over 50 full-time employees must meet certain requirements in plan benefits and costs to employees. Employers that do not comply with the affordability and essential coverage requirements of the law will be subject to penalties. Employers are required to distribute specific notices to employees and annually submit informational reports to the IRS.






